








**CUSHIONS:** 100% SPIRAL SILICON POLYESTER FIBER PADDING WITH OUTSIDE MESH IN POLYPROPYLENE. REMOVABLE CUSHION COVER. CHARACTERISTICS OF THE COVERS ARE DESCRIBED IN THE VARASCHIN FOLDER "FABRICS".
